- I. Class A Active Member who is entitled notice of, attend and vote at all meetings and each such Class A Active member shall be entitled to one (1) vote at such meetings.
- II. Class B Associate Member with no voting rights or notice who have been accepted by ordinary resolution by the board of directors.

In the event of the dissolution of the Corporation all the assets remaining shall be transferred to one or more qualified charities subject to the provisions of the Income Tax Act (Canada), amendments and regulations thereto.

**10 Additional provisions, if any**

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in furtherance of its purposes.

The directors shall serve as such without remuneration and no director shall directly or indirectly receive any profit from his position as such; provided that a director may be paid reasonable expenses incurred by him in the performance of his duties.
